- . No Reply All if responding to someone's post or request, please reply privately.
- Posting about political, religious, or social issues that do not align with EO Values.
- Engaging in one-on-one conversations in the group (move them to a private chat).

- Ofer services or products of other members without their consent.
- Post political, religious, or social issues not aligned with EO's Core Values. Post personal messages, birthday greetings, memes, or non-business-related content.


